RE: Acceptance of Roadway Easement/Right-of-Way (4030 N. Kickapoo)

### **Nature of the Request**

O'Reilly Automotive Stores, Inc. proposes to construct a new retail store at 4030 N. Kickapoo. As part of the development review process, Staff determined that a right-of-way dedication was required to provide room for future expansion of Kickapoo Street. No roadway work is planned in the short-term and the request is for long-range planning efforts and is consistent with requirements on other sites that have frontage along collector or arterial streets.

### **Staff Analysis, Considerations**

The proposed public highway easement is 2,550 square feet in total area and provides 17 additional feet of right-of-way along the owner's Kickapoo Street frontage (see attached).

### Recommendation

Staff recommends *acceptance* of the proposed *Easement for Public Highway* as supplied by O'Reilly Automotive Store, Inc.

### **Budget Considerations**

There are no budgetary impacts associated with the acceptance of this easement.

### **EASEMENT FOR PUBLIC HIGHWAY**

### KNOW ALL MEN BY THESE PRESENTS:

THAT O'Reilly Automotive Stores, Inc., a Missouri corporation, hereinafter called the Grantors (whether one or more), for and in consideration of the sum of One Dollar (\$1.00) and other good, valuable and sufficient considerations, do hereby grant, bargain, sell, convey and dedicate unto the City of Shawnee, Oklahoma, the following described lots or parcels of land for the purpose of establishing thereon a public highway or facilities necessary and incidental thereto, to wit:

To have and to hold said above described premises unto the said City of Shawnee, Oklahoma, free, clear and discharged from any and all claims of damages or injury that may be sustained directly or indirectly to the remaining lands of the Grantors by reason of the construction and maintenance of a public highway and all highway excavations, embankments, structures, bridges, drains, sight distance of safety areas and other facilities that may now or hereafter be, in the discretion of the grantee, necessary for the construction and maintenance of a public highway and incidental facilities over, across or along the above described real estate; the supervision and control of said public highway to be in such municipality, county, or other agency of the State of Oklahoma, its officers, agents, contractors and employees are hereby granted free access to said property for the purpose of entering upon, construction, maintaining or regulating the use of said public highway and incidental facilities.

Said Grantors hereby covenant that at the time of the delivery of these presents they were the owners in fee simple of the above described premises and that same are free and clear of all liens and claims whatsoever, except taxes subsequent to December 31, 2013.






**Re:** Payment to G & G Services for Vegetative Debris Removal

### *NATURE OF THE REQUEST:*

I am writing to request your approval for payment to G & G Services for vegetative debris removal from the December, 2013 winter storms.

### STAFF ANALYSIS / CONSIDERATIONS:

Winter storms brought icy and windy conditions to Shawnee during the last 2 weeks of December, 2013, creating significant tree limb damage across the city.

Various departments received numerous calls from citizens concerning how to dispose of the tree limb debris. Staff made the decision on the following course of action and advised citizens accordingly:

- 1. Citizens who could transport debris would be allowed to use the vegetative debris collection and disposal site west of Shawnee Lake # 1.
- 2. Citizens who could cut and bundle the limbs into 2 foot lengths or shorter should do so and set them at the curb for removal by Central Disposal.
- 3. If the first 2 options would not work, citizens could pile their limbs at the curb and the City would remove them using the City Manager's Emergency Spending Authority.

After contacting local tree services, it was determined that G & G Services had a contract with Pottawatomie County and that we could use that contract for provision of services. The price given by G & G Services was also the lowest price quoted.

At the same time that the service quotes were being obtained, a windshield survey was taken of the city and a 13 page list developed of addresses where debris piles were observed.

A purchase order for \$5000.00 was issued to G & G and they were given the list of locations where debris had been observed.

A temporary staff person was employed to monitor the contractor to ensure that eligible work was performed.

G & G performed the debris pick-up work for the \$5000.00 purchase order and has been paid.

G & G continued debris removal under the assumption that the same methodology applied in their contract with the county would apply to the service for the City in that the work would continue until the task list had been completed. G & G has completed work totaling an additional \$25,000.00. G & G completed this work in good faith believing they were operating under the same provisions as their contract with Pottawatomie County.

While we are not technically obligated to pay this claim, Therefore, staff is requesting that payment be made because G & G acted in good faith.

To guard against this type of situation occurring in the future, the City now has a Debris Management Plan in place which is being reviewed by the Oklahoma Department of Emergency Management and the Federal Emergency Management Agency. One of the provisions of that plan calls for a contract for debris removal service to be adopted annually with Commission approval.

#### RECOMMENDATION:

Staff recommends approval.

### BUDGET CONSIDERATION:

Cost for the payment is approximately \$25,000.

The City Treasurer/Finance Director recommends the funding be taken from fund balance.


