This requirement shall also apply to Marketplace Boulevard, provided that the street may be phased as noted in the conditions adopted by the City Commission on February 18, 2014.
- 4. Construction of public and other site improvements shall be in accordance with the engineering plans reviewed and approved by the City Engineer.

- 5. Traffic signal plans need to be submitted and approved by the City Engineering Department for signals at the Main Entrance (between lot 4 and lot 5) with Kickapoo and signal plan upgrades for the existing signal at Lowes' entrance with Kickapoo.
- 6. Traffic signal (poles, mast arms, ped crossings, controller box, etc.) at Main Entrance with Kickapoo to match the decorative style signals being currently installed on the Kickapoo Paving Project.
- 7. Street lighting along Main Entrance and Marketplace Boulevard to be decorative style (selected by City) at an appropriate spacing to provide satisfactory illumination.
- 8. The access, utility and sign easements provided to Shawnee Marketplace by the Commissioners of the Land Office (CLO) shall be noted (including book and page) and shown on the final plat.
- 9. All other applicable City standards apply.

Presentation by City Engineer regarding flooding on Buck Drive.

John Krywicki, City Engineer, gave an overview of the area that is having overflow from the creek channel into yards and streets. This area is in a designated flood plain. The old underground storm sewer system seems to be inadequate to move the water during heavy extended rainfall. Mr. Krywicki gave estimates on different ways this could be alleviated with estimated cost for these different approaches. The estimates range between \$3.7 million and \$1.9 million.

City Manager Brian McDougal and some Commissioners mentioned some cities deal with these cost by charging a storm sewer drainage fee.

The Commission agreed they will need to look at ways to improve the water flow as well as ways to fund any projects.

Ms. Kinlee Farris, Executive Director, Shawnee Convention and Visitors Bureau handed out a list of the Board Appointees of the newly formed Visit Shawnee, Inc. as well as a copy of their first meeting minutes from July 30, 2014. She then introduced Mr. Randy Gilbert, the newly elected Chairman of the Visit Shawnee Inc. Board.

Mr. Gilbert advised committees are being formed, and an attorney has been hired. He advised there is progress on acquiring their 501C6 status and hope to

have a contract to present to the City Commission within the next couple of months.

Don Lynch, Emergency Management Director, reported on the problems that face the Emergency Management team, the Police Department and the Fire Department during the time any storm shelter would be needed. The only area available for people to take shelter is in hallways and this causes the occupancy limit to be exceeded. There is also the problem of pets and food and drinks brought into the area. The emergency workers, police and fire need to be able to maneuver the halls and get in and out of the offices.

There is also the problem of people being out in the storm attempting to get to a public shelter when many times with the proper preparations, they could be safe in a substantially built building.

NATURE OF THE REQUEST:

I am writing to request your permission to advertise for proposals to provide services for snow and ice removal, debris removal and debris removal monitoring services for the City.

STAFF ANALYSIS / CONSIDERATIONS:

Standard practice has been for the past few years to solicit contract firms to aid our City Street crews if needed in removing snow and ice from the designated Snow Routes in the City. In preparation for the winter season, we are requesting permission to continue this practice.

Additionally, we have received approval from the State and the Federal Emergency Management Agency on our disaster/emergency debris management plan. SUMMARY

On August 14, 2014 an Administrative Order was issued requiring the dismantling and removal of the residential structure located at 618 E. Oakland. A public hearing was held at 9:45 AM and the legal owner, Pamela Johnson was not present. It was determined that the structure met the statutory definition of "dilapidated" and that the public interest would be best served by removal of the building.

Shawnee Municipal Code provides in Section 7-582(a)(6) that:

The property owner shall have the right of appeal to the city commission from any order of the community development director. Such appeal shall be taken by filing written notice of appeal, clearly stating all grounds upon which the appeal is based, with the city clerk within ten days after the administrative order is rendered.

Ms. Johnson appealed the decision of the Administrative Hearing Officer on August 14, 2014.

Ms. Johnson filed for a building permit in March 2014; however, the permit was never picked up and no work has been done.

Photographs are attached that indicate the condition of the property. In summary, the property is in a severe state of disrepair due to a lack of maintenance. It has not had City water service since December 2009 and there are numerous major system and structural issues with the building (electrical, roofing, foundation, etc.). In addition, there is junk and debris on the property, which is also in violation of City code.

According to the Pottawatomie County Assessor, the building is 684 square feet and was built in 1940.

RECOMMENDATION

Staff is sympathetic to Ms. Johnson's request given the fact that she clearly intended to be present for the public hearing. The public hearing notice does clearly state the address of the hearing however, and the property has an extensive history of code violations.

Staff has <u>no objection</u> to the City Commission nullifying the Administrative Order and providing Ms. Johnson with 60 days to submit a remodel permit and begin repairs on the property.

If Ms. Johnson does not proceed in due course on the improvements, Staff will proceed with appropriate administrative action after the 60 days has passed.






